## A. Sava waterway rehabilitation project

### A1. Signalling and maintenance of the signalling system

- In 2010. B&H completed the signalling system on the section rkm 211 to 343 on both banks (agreement with Croatia), and from rkm 178 to 211 on the right bank (until border with Serbia). Financed from the B&H budget.
- Maintenance of the signalling system during 2010. and 2011.



## A2. Technical documentation for rehabilitation of the Sava river inland waterway

- **Technical documentation for the section Brcko-Belgrade (rkm 234,0 – rkm 0,0 (Va navigation class);**
- **ESIA and Detailed design**
- **Demining of the right river (B&H) bank**
- **5,6 mil. Eur from IPA 2010 fond;**
- **Grant administered by the WB.**



## B. River Information Service (RIS) in B&H

- Project documentation and installation of prototype through Sava Commission;
- B&H financial participation estimated on 2,0 – 2,5 mil. Eur;
- Deadline for RIS installation for the whole Sava river 2015.



## D. Maintenance of the Sava river waterway

- Insufficient institutional development;
- Draft Rule book for maintenance completed, next step is harmonisation within the state and bodies;
- The Rule book shall define/determine relevant bodies/institutions/legal bodies in charge for maintenance.



## E. Bilateral agreements

- 1. Agreement between Government of Republic of Croatia and Council of ministers of Bosnia and Herzegovina on inland waterways navigation, its signaling and maintenance, (2004);**
- 2. Agreement between Government of Republic of Serbia and Council of ministers of Bosnia and Herzegovina on inland waterways navigation and its technical maintenance (2012).**
